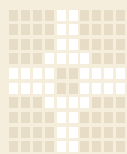


## The Stapleton's story

**Peter Stapleton was born in the parish, attended our parish school and lived his life in Jamieson Street.**



He was very involved in parish life – a member of the Parish Pastoral Council, liturgy committee, and P&F. At Mass he was a reader and communion minister. After a few weeks illness, he died unexpectedly on 22 January 1992.

Peter's mother Phyllis moved to Duhig Court soon after and died there in 1999. The whole family was closely associated with the Parish of Saints Peter and Paul in their lifetime. They wished to continue their link with the community in their death. They made a bequest to the parish in their wills.

Their gift was used to construct the bell tower, a memorial for the Jubilee Year 2000 and a permanent testimony to their generosity. It has also been used for the covered entrance at the side of the church and contributed to the new parish offices in the Parish Pastoral Centre.

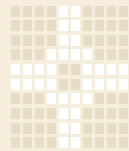

## Remember the parish in your Will

### There are several ways you can include the parish of Saints Peter and Paul as a beneficiary under the terms of your Will.



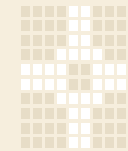
- 1 A specific bequest or legacy is a gift of a specified sum of money or the gift of a specific item (jewellery, furniture, car, etc).
- 2 A specific devise is a gift of land or other realty by Will.
- 3 A residual bequest or legacy is a gift of the balance of your estate after you have provided for all other people or institutions you wish to remember.

If you have not yet drawn up a Will, the first step is to consult your solicitor or a Trustee Company for assistance.

For those who have already made their Will, it is simply a matter of adding a codicil, or amendment, setting out your instructions. Once again your solicitor or Trustee Company will assist.

## Recommended wording

### Devises and bequests for religious, charitable and/or educational purposes. Recommended clause:



“To the Corporation of the Trustees of the Roman Catholic Archdiocese of Brisbane for the use and benefit of the Religious, Charitable and/or Educational purposes of the Parish of Saints Peter and Paul at Bulimba, Brisbane in the State of Queensland; however if this Parish is suppressed and ceases to exist in its current form, then to the new parish or parishes erected in its stead which includes the Parish named above and, if more than one, equally between them.”
